## Residential Wholesaling Legislation Signed Into Law

Pennsylvania Gov. Josh Shapiro signed Senate Bill 1173 (Stefano, R-Fayette) into law as Act 52 of 2024 on July 8.

A key legislative priority for the Pennsylvania Association of Realtors® this session, Act 52 amends the Real Estate Licensing and Registration Act to require a real estate license in order to conduct residential wholesale transactions in the commonwealth. Act 52 also ensures that consumers are made aware they are engaging in a wholesale transaction by receiving proper disclosures.

Act 52 provides uniformity, transparency and accountability to the practice of residential wholesaling, and its passage is a major victory for consumers and the real estate industry in Pennsylvania.

Act 52 will take effect in 180 days, ensuring those who wish to practice residential wholesaling will have time to obtain a license. To read more on the approval and passage of this key piece of legislation, check out PAR Just Listed.
