2017 SALES AWARDS

After months of evaluating our Annual Sales Award process, BCAR's Board of Directors voted to change our Policy & Procedures at our last monthly meeting, with respect to the Sales Awards/Annual Production Awards policy. The new process will entail every broker making the determination for the categories listed below rather than a BCAR committee.

Brokers will be invited to attend and present certificates of recognition to the individuals in your office that <u>they</u> deem worthy to award. The deadline to remit the sales application will be Tuesday, January 9th. The 2017 Sales Awards/Installation Banquet will be on Thursday, January 25th, 2018 at The Club at Shadow Lakes (see p. 4 for details).

I. ANNUAL PRODUCTION AWARDS

- A. General Guidelines
 - i. BCAR will recognize REALTOR® members who have been chosen by the Broker of Record in their respective offices for the categories that said broker deems worthy. Once category winners have been established an email from the broker will be sent to BCAR's Association Executive and Awards Chairperson for the compilation of certificates for the Installation/Sales Award Banquet. Brokers will be afforded the opportunity to present awards or designate an individual from their respective offices to be present at the banquet for the distribution and acknowledgment of these awards
 - ii. Nominee must be a BCAR member to qualify for the award in the subject year
 - iii. Award certificates will be produced by the Association and recognized at the annual banquet.
 - iv. All Awards to be turned in by January 9th of the New Year.


