The Field Report is published by the PAR Field Program which provides 28 local associations across the state with government affairs representation.

Monitoring Ordinances – The Realtors® Association of Westmoreland, Indiana and Mon Valley provided testimony addressing the concerns of spot assessments and the criteria being used to conduct them to Hempfield Area School District at their September meeting. This proposed process would affect the 25 residents who already received letters stating their taxes are being appealed and those who will receive letters when a property sells within the school districts limits. The testimony offered questions and concerns as to the criteria the school district chose to use and the reasoning for only filing appeals on those who recently purchased their homes within the district. - * Register at a **County Voter Registration Office** or other designated sites.
- * Register by mail.
- * Register at a PennDOT photo center.
- * Register at many other state government offices.

Voting on BCAR Bylaw Amendments

We will be voting on revisions to the BCAR Bylaws.

REALTOR® Emeritus Qualification Changes

The REALTOR® Emeritus program is a special membership status honoring those REALTORS® who have maintained their membership for 40 years or more. Emeritus members receive a certificate and pin to show their status, payment of National Association dues is waived for the remainder of their membership, and they are exempt from the Code of Ethics Training requirement.

FOR 2019 ONLY, members may qualify for Emeritus status if they

1) Have held membership in the National Association as a REALTOR®, REALTOR-ASSOCIATE®, or both, for a cumulative period of 40years;

AND

2) have completed at least 1 year of service at the National, state or local level.

Beginning in 2020, the service qualification will change so that at least 1 year of service* at the National level only will be accepted for Emeritus status. Service at the state or local level will not be considered.

* "Service" is defined as serving as an officer, director, committee member, federal political coordinator, president's liaison or regional coordinator to a country with which NAR holds a reciprocal agreement.

2019 is your last opportunity to apply for REALTOR® Emeritus status with the state or local service requirement.






