Why is NAR fighting 'Patent Trolls'?

The National Association of Realtors[®] issued a <u>Call-for-Action</u> to urge U.S. representatives to support H.R. 9, the Innovation Act, to stop patent trolls and protect the real estate industry from frivolous lawsuits.

A "patent troll" is a person or company that attempts to enforce patent rights against accused infringers far beyond the patent's actual value. Realtors® are targeted by patent trolls at alarming rates. That's because the real estate industry relies heavily on technology and software products to market properties. Patent trolls exist solely to purchase old patents and to use the threat of expensive lawsuits to extort money from legitimate businesses. They target Realtors® using technology such as dropdown menus on websites; website mapping technologies; on-line search alert functions; and scan-to-email technologies. In Pennsylvania alone, nearly 460 patent-related lawsuits have been filed. NAR is part of the United for Patent Reform coalition with nearly 200 other businesses – from Macy's to Adobe Systems to Facebook – to pursue comprehensive solutions to abusive patent litigation.

News from Harrisburg:

HB 1480 Amendment to Act 99 of 2000 "Municipal Property Maintenance Code"

Representative Jamie Santora has proposed House Bill 1480, which amends the Municipal Property Maintenance Code, Act 99 of 2000. The current language of Act 99 does not clearly define what constitutes as "unfit for habitation". Representative Santora's amendment seeks to provide clarification on the language, while preventing minor issues from stalling the closing of a sale. 20 Representatives have signed on as co-sponsors to this amendment, and it will be referred to the Local Government Committee, chaired by Representative Harper.

HB 1421 (Representative Helm) – Legislation to require licensure of all home inspectors in Pennsylvania

House Bill 1421, sponsored by Representative Sue Helm, implements a statewide licensure standard that all home inspectors must meet. The pre-requisites established in the legislation include: 1.) Education: high school diploma or equivalent; 2.) Successful completion of a bureau-approved training program of no less than 120 hours (including 40 in-field training hours); 3.) Successful completion of a bureau-approved examination; 4.) Secure liability insurance of \$500,000 per occurrence and deductible of not more than \$2,500; 5.) Payment of fee; and 6.) Biennial renewal: includes 16 hours of continuing education. The bill has been co-sponsored by 50 State Representatives.

<u>HB 809</u> Legislation to prevent Pennsylvania's municipalities from implementing housing ordinances that discriminate against college students

Representative Sue Helm has proposed this piece of legislation that prevents municipalities from discriminating against college students. The restrictions that municipalities are authorized to enforce would include: 1.) Based on reasonable and sufficient parking for the vehicles of the occupants of the unit; 2.) Capping the number of occupants at no more than two per bedroom; and 3.) Based on any unique health and safety concerns or unresolved code violations. Hearings are being planned by the House Local Government Committee to further discuss this legislation. The Pennsylvania Association of Realtors is currently monitoring this legislation.

SB 877 Property Assessment Appeals Legislation

State Senator David Argall has proposed Senate Bill 877, which specifies that taxing authorities may only appeal assessments when the property a.) has gone through a countywide reassessment; b.) been divided into smaller parcels; or c.) experienced a change in its productive use. A retroactive remedy is included to allow owners to appeal for a reduction to prior levels.

News from Washington:

RESPA/TILA

The Consumer Financial Protection Bureau has formally approved the postponement of RESPA/TILA integration until <u>October 3, 2015</u>. The Know Before You Owe rule will require the submission of two new documents: the Loan Estimate and the Closing Disclosure forms.

According to the <u>CFPB</u>, the <u>final rule</u> issued on July 21st included corrections to two of the provisions in the original document.

H.R. 9: The Innovation Act

The National Association of Realtors has issued several calls-to-action in support of H.R. 9: The Innovation Act, which would provide protection to the Realtor community from patent trolls.

1031 Like-Kind Exchanges

Overall tax reform is unlikely during a presidential election, however, there is a chance that Congress address corporate tax reform. In the unlikely event that this occurs, NAR is proactively collecting testimony in regards to <u>1031 like-kind exchanges</u>

For example:

IRS mileage method or the Actual Method GVWR – Gross Vehicle Weight Rating up to \$25,000 deduction Home office deduction Commuting miles deductible from administration office to business office Medical Insurance Reimbursement Entertainment deductions

CONTINUING EDUCATION COURSE DESCRIPTIONS

Course 1. PROFESSIONAL ETHICS IN REAL ESTATE PRACTICE

Real estate professionals have both legal and ethical duties when working with consumers and other licensees. This 3.5 hour program will present common ethical dilemmas and propose methods to resolve them. It will also satisfy NAR's requirement for quadrennial ethics training for REALTORS©.

Course 2. CHANGES IN FINANCE AND SETTLEMENT PROCEDURES: THE IMPACT ON CONSUMERS AND LICENSEES

This 3.5 hour program is designed to educate licensees about newly adopted rules and documentation requirements. The use of these new documents will require expertise on the part of licensees to ensure that transactions are completed in a timely manner and in accordance with the law. Participants will review and become familiar with the documents and time frames required and, develop business practices which benefit all parties involved in the transaction.

Course 3. CONSUMERS, LICENSEES AND AGREEMENTS OF SALE: THE BASICS

Consumers rely on the expertise of licensees to guide them through the process of buying and selling real estate. The focal point of any transaction is the Agreement of Sale. This 3.5 hour program will focus on licensees' duties regarding preparation and use of properly completed Agreements of Sale. The PAR standard from will be used as the basis for helping licensees understand their duties, obligations and limitations regarding this important document.

Course 4. AGREEMENTS OF SALE – BEYOND THE BASICS: PROPER USE OF CONTINGENCIES, ADDENDA AND SUPPORTING DOCUMENTS

Every real estate transaction is unique. While the key elements of an Agreement of Sale may be clear and easy to address, they may not adequately deal with specific circumstances related to the transaction. This 3.5 hour program will address how licensees address these issues without engaging in the unauthorized practiced of law.


