

### Municipal Deed Registration Act

Many of you may be aware that Governor Rendell signed the "Municipal Deed Registration Act" into law late last year. The Act is intended to prohibit municipalities from requiring the registration of deeds prior to recording in the County Recorder of Deeds office. The law accomplishes this by requiring the owner or the "agent" working on behalf of the owner to register the deed with the municipality within two days of recording the deed with the county. The legislation was drafted in response to some municipalities holding up deed registration to force compliance with their use and occupancy requirements.

The Municipal Deed Registration act does not define "agent" which unfortunately has an unforeseen consequence. Many municipalities are passing ordinances to ensure compliance with the law. In keeping with the original language, the municipalities require the owner or agent acting on behalf of the owner to register the deed within the two day limit prescribed by law. The ordinances I have seen so far impose a \$600 fine on the owner or agent acting on behalf of the owner if they are delinquent. The question is: what is the definition of agent?

PAR has sought legal opinion to determine the liability of REALTORS®. In the meantime, you are encouraged to keep an eye out for deed registration ordinances. I will be happy to help wherever I can.
